Commercial Food Waste Recycling is Here

Harrison Industries has entered a new era in recycling. This year, working with our partner cities and our partners at Agromin and Gold Coast Recycling, we have launched a robust commercial organics/food waste recycling program that involves every business we serve.

“All of our commercial customers must now recycle all of their organic waste including food waste,” said Harrison General Manager Donnie Harrison. “Unless they have a waiver* (see end of story for details), they must be doing this.”

The intensive effort is for a vital cause: the Earth. By recycling commercial organic waste including food waste – into compost, animal feed and other natural products – we are diverting materials from the landfill, where they’d release methane gases that destroy our environment.

So far, our commercial food waste recycling efforts have gone well, said Harrison spokeswoman Nan Drake. “We are off to a great start,” Drake said, “but there is much, much more to do. Cooperation is the key and making sure everyone understands that this is not a voluntary program but a mandate by law.”

SB 1383

Recycling food waste and other organics isn’t just practical; it’s the law. Specifically, California’s Senate Bill 1383 adds food material into the organics equation that also includes green waste (e.g. landscaping and

At Brophy Bros.: ‘We Recycle Every Bit of Food Waste’

Brophy Bros. Clam Bar and Restaurant in Ventura Harbor Village is a beacon of sustainability that has recycled its food waste since long before it was mandatory.

“We’ve been doing it at least since I got here, in 2015,” said Tyler Carlisle, operations manager at the popular harborside restaurant, at 1559 Spinnaker Drive.

Harrison has offered food waste recycling services to restaurants and other food-producing businesses for many years, but few have used it as effectively as Brophy Bros.

“We recycle every bit of food waste, which is unique in my experience, and I’ve worked in several restaurants,” Carlisle said. “In most places, the bussers scrape the plates at the tables, before they go to the back, and all that food is lost. Here, we send the dishes with all the food on them to the back and they get separated by the dishwashers, who recycle it all. This is just standard here – as it should be everywhere.”

agricultural materials).

Signed into law in 2016, SB 1383 is a cornerstone in California's effort to reduce by 75% of 2014 levels the total amount of landfilled organics, by 2025. The law took effect on Jan. 1, requiring jurisdictions to inspect businesses that generate food and other organic waste, to assure they are recycling everything possible.

Harrison is working with our partner communities to get our commercial customers in the organics recycling program. Our contracts/compliance field supervisor, Donald Sealund, and his team are in the field calling on all business owners to help them understand the law and either set them up in the program or assist with waivers.

"This is going to take everyone's cooperation," Sealund said. "It's a big one, but it is absolutely necessary."

New Local Recycling Facilities

To meet the new sustainability needs, industry leaders and jurisdictions statewide have had to invest in recycling infrastructure. Locally, our community partners at Agromin have worked with us and Gold Coast Recycling, as well as our partner cities and the County of Ventura, to bring two key facilities online:

◆ **MOUNTAIN VIEW** in Oxnard is now

permitted. The equipment has been ordered and onsite improvements are underway. This facility will handle source-separated food material commercially; the timeline is set for it to be ready later this year.

◆ A decade in the works, **AGROMIN'S LIMONEIRA** compost facility in Santa Clara Valley is now a fully permitted commercial operation that can take food waste. The state-of-the-art facility received final Ventura County approval on Feb. 8. Expanding on a small existing operation, Limoneira now includes a fully permitted commercial compost facility that can handle commercial and residential food waste. This remarkable place has the ability to use organics to create renewable energy, providing a great benefit to Ventura County.

Electronic, Hazardous Waste Disposal Available in Ventura

The City of Ventura invites local business owners and residents to safely dispose of their electronic and hazardous waste.

Household Hazardous Waste (HHW) disposal is available for city residents during free monthly HHW collection events, held the third Saturday of every month except December, from 9 a.m. to 2 p.m., at Gold Coast Recycling, 5275 Colt St., Ventura.

Appointments are required; visit www.cityofventura.ca.gov/hhw or call 805-652-4525. Local business owners interested in participating are required to call 805-652-4525 to schedule



hazardous waste disposal as it is not taken during residential drop-off times.

Electronic waste disposal also is available at Gold Coast, from 7 a.m. to 3:30 p.m. daily except Sunday. The disposal of e-waste – basically any item with a circuit board – is free for Ventura residents (with valid IDs). Local businesses can drop off their e-waste, as well, but

fees may apply.

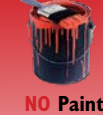

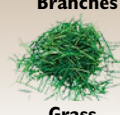
